Using the *2013 CAEP Standards* (2013) and *CAEP Evidence Guide* (2015), Railsback will familiarize webinar participants with the CAEP standards, the need to establish reliability and validity standards, the characterization of reliability and validity in CAEP guidance, and CAEP recommendations for sources of validity.

**12:35–12:50 p.m. Discussion of the Types of Instruments That CAEP Has Reviewed and Common Challenges in Meeting CAEP Standards**

Railsback will share types of teacher candidate evaluation instruments reviewed by CAEP. He will also present challenges educator preparation program staff face in meeting CAEP standards for reliability and validity. **12:50–1:25 p.m. Discussion of Process to Develop and Examine the Reliability and Validity of the Student Teacher Observation Tool (STOT)**

The presenters will discuss the steps that members of the North Dakota Common Metrics Project took to develop and assess the reliability and validity of the STOT.
