Description

Preliminary research suggests that school closures related to COVID-19 will have a negative impact on student learning, potentially exacerbating achievement gaps. As schools and districts reopen, they will need to assess the impact of disrupted learning and use the data to inform instructional practices. This webinar shares considerations for conducting assessments when students return to school and describes what resources are needed to effectively implement the assessments in different scenarios (online, in-person, hybrid). Presenters from two districts share their considerations and strategies for implementation.

- 2. Discover strategies from two school districts for revising their assessment plans following school closures and remote learning.
