

High-Quality Micro-credential Criteria

Category	Criteria	In what ways does/doesn't the example align?
Content	 Specificity: Title clearly describes the competency. Micro-credential is narrowly focused on a discrete skill or competency. Micro-credential can be stacked with others addressing related skills. Importance: Evidence-based Standards-aligned Relevant to authentic teaching contexts 	
Supports for learning	 Accessible, high-quality, and comprehensive resources and supports Mechanism to ask questions Multiple types of job-embedded learning opportunities (if facilitated learning opportunities are provided) 	



Category	Criteria	In what ways does/doesn't the example align?
Assessment	 Clear, measurable definition of proficiency Transparent and detailed rubric Competency-based performance assessment (not a multiple-choice test of knowledge) Orientation toward reflection Consistent scoring 	
Feedback	 Rubric-aligned Supportive Timely
