In groups of 8-10, participants will meet at tables to discuss the Practice Guide. A facilitator for each group will record and report out their responses and questions.

Key Activities:

- 1) Review overall structure of Practice Guide, note that all PGs are the same. (5 Min)
- 2) For each recommendation (Review one per group) (50 min)
 - a. Review the Brief Summary of Evidence—How much can we trust this recommendation?
 - b. Review the example strategies in the text—Have the group read small sections silently, then ask different members to lead a discussion on each.
 - i. Are these clear? What questions do you have about them? Do you feel that you could implement this strategy? If not, what else do you feel you need to know?
 - c. Review the roadblocks in the text—Have the group read small sections silently, then ask different members to lead a discussion on each.
 - i. Are these clear? What questions do you have about them? Are there others in your school/district that are not listed here? Do you have ideas for how to overcome them?
- 3) Wrap up – Record questions for expert (5 min)
